#### **Encouraging Budget News Means TVEA Will Negotiate for Compensation**

TVEA has shared with you previously that the new Local Control Funding Formula the state is using has set up some California districts for a lot of new funding over the next 8-10 years. Districts with a large number of needy students—EL learners, children in low-income families, foster kids—will see significant increases in funding, while districts like TVUSD, with fewer students in these categories, will see smaller increases.

However, there WILL be an increase in funding for our district, and according to the Governor's Proposed Budget, it may be larger than planned for next year. The first priority for our TVEA leadership and the Negotiations Team will be focusing on an increase in compensation for all members! Bargaining teams meet again on January 30 to begin serious discussions on financial matters. Feel confident your team won't settle for anything less than an increase in compensation this year! District leaders are fully aware that this will be our focus in negotiations meetings and we will continue to pursue this until we have finalized a deal.

#### Two reasons why we're feeling positive about this, for the first time in many years:

The December First Interim Report for TVUSD, shared at the Dec. 10<sup>th</sup> School Board meeting (and later analyzed by our Bargaining Team and CTA staff) shows more money than the district anticipated in this school year's budget. But it also shows more spending, so it doesn't mean a large amount of money has been freed up. Much of the spending is on **new positions** that weren't projected or reflected in the district's initial budget, spending which impacts our membership and students positively. Teachers were hired because of the new 24:1 ratio the state mandated for CSR; the district nurse we have been advocating for over the last few years was recently hired; special ed teachers were hired due to the increase of special needs students; and TVUSD hired many permanent speech and language pathologists, rather than using consultants on contracts. Beyond this new spending, though, there is still money that can be used for pay increases for employees in all groups.

The Governor's State Budget Proposal includes \$10 billion in new funding for schools across the state. Gov. Brown has also included plans for a "rainy day" savings fund that could help make school funding more stable in years that revenue to the state decreases. Your Negotiations Team will be participating in analysis meetings about the Gov.'s budget proposal with both School Services and CTA's Negotiations and Organizational Development experts.

Remember that at this point the state budget is a proposal, and the state legislature could make many changes to it before the final budget is passed later this year. We'll report more in February!



#### LCAP Committee Delves into Data, Discusses Ideas for Next Year

TVUSD's Local Control Accountability Plan Advisory Committee has met several times since October to analyze data and discuss priority concerns for a 2014/15 plan. Administrators, teachers (TOSAs, classroom teachers, and TVEA's president), parents, and community members are part of the Advisory. The discussions take place in small (mixed) groups, followed by a share-out to the whole group. Discussion has centered on strengths and concerns in each area we've studied, and identifying the barriers that get in the way of generating success in the area. Most recently our discussion has been on student engagement (attendance, truancy, drop-out and graduation rate info), but previous meetings have focused on needs across the district for English language learners, students in low-income families, and special ed students. There has also been discussion about math achievement rates for TVUSD students.

## School Boundary Changes Discussed at Special School Board Meeting

On Jan. 14, the School Board held a special meeting to hear the district's proposal to change boundaries for elementary, middle, and high schools. Board members had the chance to ask questions of Janet Dixon, Facilities Development Director and articulate concerns. Parents also addressed the board with questions and opinions.

Four informational meetings are scheduled for the community to hear the plan and provide input:

Feb. 5 at TMS, Feb. 6 at GMS, Feb. 12 at DMS, and Feb. 20 at MMS (all begin at 6 pm)

The School Board had previously identified "aligning attendance" at all levels as a high priority, meaning to make it consistent which schools each school feeds into at the next level. Other important goals considered as the plan was put together were planning ahead for new populations, minimizing the distance to schools, and spreading the density of lower socioeconomic status populations, and equalizing school density (not enrollment, as all schools are slightly different in size). Note that current students will be able to finish school at the school they're attending.

## Common Core Steering Committee Meetings have begun! ASSESSMENTS will be the first focus topic

The Common Core Steering Committee met for the first time on Dec. 18<sup>th</sup> and scheduled our next two meetings for after school on January 23 and February 27.

At our first meeting:

- We discussed the purpose and norms of the group
- The committee members agreed to be solution-minded and results-oriented in our work.
- The committee committed to working towards a positive implementation of Common Core Standards across the district that emphasizes student success.
- The committee discussed the need for improved, clear communication to every level and to every site about Common Core implementation--and the need to monitor this process. This will be one of our projects as a group.
- We discussed the need for clarification of the current systems for teachers and administrators to provide feed-back and input with regard to the CCSS implementation. We are committed to refining these systems—or creating new ones if needed.
- We decided **Assessments** will be the first focus topic for the committee.

#### Confused about how insurance is showing up on your paystub?

In the center of your check there is a column entitled, "Net Pay Summary." If you look under "Payroll Deductions," you will see the name of your Medical Plan (i.e. Blue Cross PPO Plan B, Blue Cross HMO, Kaiser, etc.), and next to the Medical Plan Name will be your medical premium. There may also be a deduction shown for Delta/VSP. If you add the 2 dollar amounts together, that should equal the total amount of your monthly premium. Note the district pays \$743.50 towards the insurance premiums of each full-time employee, per our contract.

P – is for Perfect, you were the best!


#### Technology Reminder!

#### Time to Apply for a CTA Scholarship for Your Child?

Because you are a working and dues-paying member of TVEA/CTA, your dependent child might qualify for a college scholarship, and now's the time to get started on an application! All applications are due to CTA for consideration in February. Please go to www.cta.org/scholarships to apply electronically for any of the scholarships below.

CTA offers scholarships to graduating high school students:

**Dependent Children**—This scholarship is for students with a high, un-weighted grade average and high academic achievement. Up to 35 of these are awarded at \$5000 each year. Applications are due Feb. 7<sup>th</sup>. This scholarship requires a recommendation from an educator (not family) and a community member. There is an opportunity to explain how medical, physical, or emotional difficulties may have affected grades. The essay requires a discussion of personal vision, unique qualities, and future goals. School and community activities are a factor in the points system that the application is judged on. The highest scoring applicant is granted an additional Ralph J Flynn Memorial scholarship.

**Del A. Weber Dependent Children for Children Attending Continuation High School/Alternative Programs--**CTA offers one scholar-ship in the amount of \$5,000 to a dependent child of an "active," retired or deceased CTA member who is attending or attended a continuation high school or an alternative education program. Students must have a GPA of at least 2.0. Applications are due Feb. 7<sup>th</sup>. This scholarship requires 2 letters of recommendation from educators (not family). The essay requires a discussion of personal vision, unique qualities, and future goals. School and community activities are a factor in the points system that the application is judged on.

Martin Luther King, Jr. Memorial Scholarship—This scholarship is to aid and encourage members of ethnic minorities in preparing for teaching-related careers in public education. (Ethnic minority groups identified are African American/Black, American Indian/Alaska Native, Asian/Pacific Islander, or Hispanic.) The number of scholarships offered each year varies, depending on donations from CTA members to the fund. (Last year, 2 \$6000 scholarships were awarded, 16 \$4500 scholarships were awarded, and 9 \$3000 scholarships were offered.) Applications are due Feb. 21<sup>st</sup>. One letter of recommendation is required. The personal statement requires discussion of how the scholarship will support the student's goals, how the student plans to complete the program of study being undertaken, and the personal attributes and unique qualities that will help the student succeed as a professional in public education. Note the Martin Luther King, Jr. scholarship requires the ethnic group applicant to either have a parent living in CA who is an active member of CTA, be a member of CTA, or be a member of SCTA.

**If your child is presently in college, pursuing a career in public education**—and a member of Student CTA, these scholarships are offered:

**Gordon Bittle Memorial Scholarship for SCTA**—3 scholarships of \$5000 are awarded. Applications are due Feb. 7<sup>th</sup>. This scholarship requires a recommendation from an educator (not family) and a community member. Students must have a high, un-weighted GPA. There is an opportunity to explain how medical, physical, or emotional difficulties may have affected grades. The essay requires a discussion of personal attributes, unique qualities, and future goals. School and community activities are a factor in the points system that the application is judged on.

**The Martin Luther King, Jr. Scholarship** can apply to a dependent of a TVEA/CTA member who is one of the identified ethnic groups and who is pursuing a degree or credential in public education and is currently in college. Deadline to apply is Feb. 21<sup>st</sup>.

#### Are There Any Scholarships from CTA for ME?

Yes, CTA offers scholarships to members, too.

Scholarship for Members—This program offers up to five scholarships in the amount of \$3,000 to current active CTA members completing college coursework. In addition, the highest-scoring applicant is awarded the Alice Piper American Indian/Alaska Native Memorial Scholarship for the highest scoring member applicant. Applications are due by February 7<sup>th</sup>. This scholarship requires a recommendation from an educator and a community member. College coursework must show high achievement. There is an opportunity to explain how medical, physical, or emotional difficulties may have affected grades. The essay requires discussion of future aspirations in the field of education or training and how the scholarship will benefit the applicant. A school and community professional record is a factor in the points system that the application is judged on. College transcripts are required.

The **Martin Luther King, Jr. Scholarship** can apply to a TVEA/CTA member who is one of the identified ethnic groups and who is pursuing a degree or credential in public education. The deadline for applying is Feb. 21<sup>st</sup>. See information above.

## TVEA "Dollars for Scholars" Scholarship Applications Are Available!

You can encourage your high school senior (dependent child)--or senior students interested in going into public education as a career—to apply on-line for a TVEA scholarship through the "Dollars for Scholars" program. To fill out the application, go to:

A TVEA committee of members (that does not include any parents of seniors) convenes to review all applications this spring and award scholarships. Students must have a GPA of 3.0 or higher to qualify for this scholarship. Through your membership dues, TVEA awards scholarships to children of members (highest priority) and students interested in going into public education.

An essay rubric is available on the website to guide the writing portion of the application, along with guidance in the application process and FAQs. Applications MUST be submitted by February 1, 2014 at 11:59 P.M. We recommend getting started on this application NOW!

In addition to the TVEA scholarships, individuals, school sites, PTA, and community groups offer many scholarships that your child can apply for at the same time!

## Athletics Grant Can Subsidize PE Expenses

California Casualty offers the Thomas R. Brown Athletics Grant annually to provide support to public high school sports programs that have been negatively impacted by reduced budgets. Awards are granted to select public high school athletics programs. The grant must be used to help subsidize school sports programs in ways such as purchasing new equipment or paying for competition travel costs, and it can't be used for individual student awards.


January 15 is the deadline for grant consideration in the current school year. Applications received after January 15 will be considered for next year's grant program.

## Help a talented student with a disability win \$2,500 for college

The Standard is once again partnering with Incight, a nonprofit dedicated to reducing barriers between high school and college for students with disabilities, to offer one-time scholarships in the amount of \$2,500 each to eight students nominated by California Teachers Association (CTA) members.

Any active CTA member in good standing may nominate up to three students for the 2014 Incight Scholarships sponsored by The Standard. To be eligible, the student must have a documented physical, learning or cognitive disability, be at least a senior in high school and plan to enroll full-time in a vocational school, two- or four-year college or university for the 2014-2015 school year.

## Don't forget your \$250 deduction for classroom supplies on income tax form!

If you are a teacher, and you paid for classroom supplies and other materials out of your own pocket, then you can claim those expenses as a tax deduction.

Limits: You can claim up to \$250 of classroom expenses for supplies, materials, books, software, and so forth. If both you and your spouse are educators, you can both claim up to \$250 of expenses for \$500 total on a joint return. Any classroom expenses in excess of these limits can be deducted as an employee business expense, which is a miscellaneous itemized deduction subject to threshold of 2% of adjusted gross income.

Qualifications: You are a teacher, aide, instructor, counselor, or principal, and worked in a school at least 900 hours during the school year. Only grade school and high school educators qualify (kindergarten through 12th grade). If your aides spend money on supplies, make sure they know about this! From the IRS:

"If you are an eligible educator, you can deduct from gross income a portion of your qualified expenses. You can deduct these expenses even if you do not itemize deductions on Form 1040, Schedule A. This deduction is for expenses paid or incurred during the tax year. Previously, these expenses were deductible only as a miscellaneous itemized deduction subject to the 2% of adjusted gross income limit." (Educator Expense Deduction, Tax Topic 458) Tax Law: The deduction for educator expenses is found in Internal Revenue Code Section 62(a)(2)(D) and Section 62(d)(1).

Note at this time the legal deduction is not scheduled to continue for 2014.

#### Dues deduction on your taxes

You can also deduct the dues you pay for union membership. Full time employees paid \$1064 in 2013 towards TVEA, CTA & NEA Dues. If you are a job share or part time employee the dues you paid are proportionate with the amount you work. (IE. 50% job share paid \$532 in dues for 2013).

#### What is CTA's Negotiations and Organizational Development Department?

Local associations receive advice, resources, expertise, and financial analysis from the Negotiations and Organizational Development Department (NODD) of CTA. NODD works in the areas of <u>bargaining</u>, <u>training</u>, <u>budget analysis</u>, <u>mediation</u>, <u>fact-finding support</u>, <u>organizational development</u>, <u>and health benefits strategies</u> to assist our CTA staff in local and regional offices -- and local association leaders-- to achieve the best possible contracts for our members.

#### The department:

- •Supports local bargaining teams during mediation, fact-finding, and organizing around bargaining issues. In addition to School District Budget Analysis, Bargaining Advisories are sent to staff on topics that may arise during negotiations
- Analyzes the State Budget for staff and members and explains the implications and uses for this information for chapter activities.
- Coordinates and implements training for the Presidents Conference, Summer Institute, and CTA Issues Conference.
- Develops, coordinates and delivers multi-day training sessions for CTA staff members to help ensure they remain current on relevant issues.
- •Uses 2 CTA software programs that are designed to assist CTA staff and bargaining teams. Budget Essentials for Negotiations (BEN) analyzes school district budgets and Salary Schedule Analysis (SSA) allows staff and leadership to accurately cost out salary, benefits, step and column, and other aspects of the salary schedule.
- Maintains CTA Search, an additional resource available to chapter presidents, bargaining chairs and CTA staff.
- Provides assistance as consultants to CTA workgroups and State Council committees.
- •Responds to requests from leaders, members, staff and the general public for research about California public schools, public education and other topics of interest.

Without the continuing expertise and resources NODD provides local associations, our members would be unable to negotiate with "hard" and critical information.

In addition to using NODD for advice in negotiations, TVEA leadership also consults with other local associations regularly to be "up" on what is happening in the moment with negotiations in other districts.

Seventy or Eighty votes across the Riverside and San Bernardino counties could be enough to get you elected! Note this process does NOT go through TVEA.
